Upon payment of Stud Fee and request, the STALLION OWNER does hereby agree to breed the purebred STALLION to the MARE in accordance to the terms detailed herein. All information and fees provided are believed accurate but all fees, except Stud Service Fee, are subject to change based on market conditions, availability and service provider.

#### **BREEDING TYPE & ORDERING – ARTIFICIAL INSEMINATION**

Cooled fresh semen is collected for artificial insemination (AI) Feb 1 - Aug 31 and is available first ordered, first served. UPS collections are available Monday-Friday on non-holidays, weather permitting and must be ordered by 6PM eastern on the day before collection. Courier and counter to counter collections are available by appointment. On-farm AI provided by appointment with VETERINARIAN.

refundable if the mare owner de	cides not to breed the mare.

\*DVM collection fee includes veterinary supervision of collection, handling, extension and all analysis of semen. DVM will provide Client a full written semen report detailing quality, density and motility and will be available for consult with Client's DVM upon request. Semen video provided for all collections.

Deposit or Stud Fee may be transferred to another mare in the same year pending the approval of the mare by the STALLION OWNER. Any remaining stud fee must be paid in full to STALLION OWNER prior to the first shipment of semen.

Air shipment of semen counter to counter is recommended shipping method. Contact STALLION OWNER for details. The Shipping Fee will be quoted based off actual online estimates but are subject to change. The cost of each shipment must be paid in full to Crying Coyote Farm, LLC prior to the shipping.

Semen will be shipped in a cooled semen shipping container. The CLIENT does not need to return the shipping container and can choose from the recommended Equine Express II (which is preferred for shipping up to 48hrs) or the EquiSave (which is a more economical box for up to 24hrs).

On-site mare care is available at Crying Coyote Farm with veterinary services provided by Daniels & Daniels Equine Services. CLIENT is required to set-up customer account with Daniels & Daniels prior to delivery of MARE. Supplemental mare care agreement will be provided to CLIENT.

### MARE REQUIREMENTS

The CLIENT certifies that he/she is the sole owner of MARE, or has full authority to enter into this contract, on behalf of the owner(s). The CLIENT represents and warrants that MARE to be bred is healthy and in sound breeding condition. STALLION OWNER encourages CLIENT to have MARE current on worming, vaccinations and a clean uterine culture plus cytology done, before insemination. If registered, a photocopy of the MARE'S papers, showing both sides, must be furnished and returned with this contract, as one of the requirements.

#### LIVE FOAL GUARANTEE

Should MARE fail to be in foal after initial insemination, STALLION OWNER agrees to ship cooled semen for a repeat service AFTER receipt of statement signed by CLIENT's veterinarian confirming that mare is not in foal and payment of collection and shipping fees. MARE is entitled to return breeding privileges for ONE season following the initial breeding. The contract is not transferable. Should MARE not produce a live foal (i.e. a newborn foal that stands and nurses), CLIENT is entitled to return breeding. This guarantee shall only apply if the STALLION OWNER is notified in writing within 72 hours of the foal's death. A statement of details by CLIENT'S veterinarian must follow within 10 days or the guarantee becomes null and void. This clause is also binding in case of abortion. If the mare absorbs her pregnancy, verification of this fact is required from CLIENT'S veterinarian. Should STALLION die or otherwise be unavailable for use, CLIENT shall be refunded the stud service fee. All other fees are non-refundable for any reason and subject to increase.

#### FOAL REGISTRATION

The CLIENT will be issued a valid breeding certificate for the WPCSA and/or ISR/OLD NA by the STALLION OWNER when MARE is checked in foal, all paperwork has been returned, and all fees and/or expenses have been paid. If information for registration provided by CLIENT is inaccurate, CLIENT is responsible for any fees or fines from breed registry that are required to correct registration.

#### **ON-FARM BREEDING ADDENDUM (if applicable)**

CLIENT will pay all veterinary related expenses directly to VETERINARIAN including insemination. CLIENT will be responsible for on-farm mare care fees and payment is to be made to Crying Coyote Farm upon return of MARE to CLIENT (after breeding).
